Dear Mr. Garzella:

At the request of Mr. Al Irvine, I would like to up-date our proposal to seal three oven chambers.

PROPOSAL:

The leakage is best stopped when sealed at the initial leak point. Ovens should be left empty for a period of time (24 hours minimum) to allow de-carbonization. The joint between the roof block and the wall should be ceramic welded. Pressurizing the flue chambers and visually locating the flames leaking into the oven chamber should identify all open joints across the oven. These joints should then be welded. Charging holes should be inspected and welded with fireclay weld powder. After all open joints and cracks are welded; the oven should then be grouted. This is accomplished by drilling through the top course (paving) mortar joints of the walls to a depth of approximately 18". Pipefittings are placed into the holes and grout is pumped under high pressure into the holes and back fills from the roof block-wall joint to the top course. Our product Super Grout 85 is used to perform the grouting procedure.

Ovens should then be patched on the end flues with trowel patching material and jamb spray, then pressure dusted to seal the remaining leaks that were too small for welding.

This proposal can be achieved only on a time and material basis due to the unknown extent of leakage per oven.
